*The Night of Terror: Wyoming Game and Fish's Latest Attempt to Close the Book on the Mark Uptain Tragedy*

Below are a few news articles on the report. The one by Mike Kosmrl of the *Jackson Hole News and Guide* is particularly disturbing as it feeds the WGF frame that the bear behaved abnormally, when it really behaved as you might expect when a bear is drawn to a carcass.

The report was released, not accidentally, as the Wyoming legislature considers several anti-bear proposals, and seems intended to amp emotions, which the *News and Guide* article further fuels.

#### **▪ NPR Story Highlights Hostility to Grizzlies**

- Last week, several conservation groups sent a letter to government bear managers asking that the most recent, but dated, analysis of human-grizzly bear conflicts, reported in 2009, be updated and implemented. The Interagency Grizzly Bear Committee indicated that the issue will be discussed at its spring meeting.
