IN THE NEWS:

• The Latest on Delisting

○ On December 21st, the US Fish and Wildlife Service (FWS) filed an appeal of the rule that recently restored Endangered Species protections for Yellowstone region's grizzlies. The agency joined the states of Wyoming and Idaho, the NRA, Safari Club and other hunting groups that are also challenging the court's decision.

○ Delisting of the Northern Continental Divide Ecosystem (NCDE) grizzly bear population is officially on hold pending the outcome of the appeals on Yellowstone delisting. But, Montana officials are paving the way for delisting by adopting new rules intended to demonstrate that they have an adequate system in place to manage grizzlies, if federal protections are removed. In this article, Montana officials say they will maintain a minimum of 800 grizzlies in the NCDE. How they will achieve that is a mystery, since they and other agency representatives have refused to protect and monitor habitat, and consider the newly codified Conservation Strategy to be a set of guidelines, rather than binding regulations.

Recently, the Western Environmental Law Center filed a letter of intent to sue the FWS, which continues to allow hunters to bait black bears with glazed donuts and rotten fruit in grizzly bear habitat in Idaho and Wyoming – even though feeding bears or leaving out garbage is prohibited. Go, WELC!

▪ **Terror Entrepreneurs, Revisited**

We recently began regular updates on what David calls “Terror Entrepreneurs,” named after those who incited the burning of so-called witches during the Early Modern European Witch Craze as a way of consolidating their power. The term seems apt to describe what regressives are doing on the grizzly bear front.

○ Outgoing Park County, Wyoming, Commissioner Loren Grosskopf said that one of his greatest disappointments was the relisting of the Yellowstone grizzlies, with this: “In the long run, we’ll win. This may take a lifetime. To me, the only answer, and really it’s been the answer all along, is Congress needs to act. Just like they did with the (gray) wolves.”

What a revealing admission. Grizzlies are not a species to be cherished, merely controlled. At least with the Democratic-controlled House, legislative delisting has become more difficult.

○ Outfitters in British Columbia recently challenged the government’s ban on trophy hunting of grizzlies, citing economic impacts on the industry. The government banned hunting of

grizzlies a year ago after a sustained, high-profile campaign that showed overwhelming public opposition to the practice. Studies also show that bear viewing generates more economic benefit than does hunting.

○ In recent weeks, grizzly bear experts in Canada have refuted claims that there is a “plague” of grizzly bears in the Yukon that contributed to the deaths of a mother and child last month. Outfitters have been using the fatalities to argue for killing more grizzlies. Scientists say that Yukon’s grizzly bear population is stable, and that slaughtering bears is not the answer. Grizzly bear expert Dr. Steve Herrero said, “If you want to try to hunt bears to the point that we are eliminating danger to people, you’d be in for a blitzkrieg, an orgy of killing that wouldn’t solve the problem but sure would create a lot of havoc.”

▪ **Trumping Endangered Species, Parks**

We can all breathe a sigh of relief that the Farm Bill, passed before the Christmas recess, did not gut the Endangered Species Act (ESA), or legislatively delist grizzlies. But, we are not out of the woods...

○ The Trump administration is finalizing new rules that will remove the backbone of the landmark law by allowing economics, rather than science, to dominate decisions. Here is a new report by the Endangered Species Coalition on Trump’s “Extinction Plan:”
