#### ***Anti-grizzly Fever Grips Wyoming, Again*** By Louisa Willcox

My latest essay focuses on the anti-bear fever gripping Wyoming, again, in the state legislature, Wyoming Game and Fish Department, as well as, the governor's office. State bills go as far as allowing a grizzly bear hunt, even though it has been prohibited by a federal court.

### **- Wyoming Releases Final Report on Mark Uptain Fatality**

Last week, Wyoming released the final investigative report on the tragic death of outfitter Mark Uptain by a grizzly last September. A mother grizzly and her yearling cub appear to have been attracted to a dead elk, shot the day before, that Uptain and his client were dressing out.

The report reinforces previous conclusions by OSHA that bear spray, if properly deployed, could have averted the disaster. By repeating state officials' mantra that the bears' behavior was "abnormal," reporter Mike Kosmrl reinforces stereotypes of grizzlies as "monsters of god." The public deserves better reporting especially when stakes and emotions are so high.

### **- Researcher Joy Erlenbach's Life Revolves Around Getting Along with Grizzly Bears**

By contrast to Wyoming, reporter Wilson Criscione did a great job with this delightful, detailed story about Washington State University researcher Joy Erlenbach, who studies grizzlies in Alaska's Katmai Park. She shares a very different perspective than what you are hearing in Wyoming, with this: "I would like to see people realize that you can peacefully coexist with these animals, that they're not out to get you all the time."

Her success coexisting with bears rests in large measure on her ability to read bear behavior as one might a dog's. "I personally think [grizzly populations] should keep growing and expanding and that the *people* need to change," she concludes.

David is also quoted in this article, offering this: "I think it's wrongheaded to think of it as us versus bears, because our fates are intertwined."
